The Federal republic of Somalia has received financing from the United Nations Development Program (UNDP) toward the cost of the Joint Programme for Support to the Electoral Process in the Federal Republic of Somalia and intends to apply part of the proceeds toward payments under the contract for the Supply nine (9) four-wheel-drive pick-up vehicles double cabin for the National Independent Election Commission (NIEC).
- 2. The Ministry of Finance now invites sealed bids from eligible bidders for the following items to be delivered to the Ministry of Finance, Villa Somalia, Mogadishu within three weeks after contract signing:
 - Nine (9) four-wheel-drive pick-up vehicles double cabin for the National Independent Election Commission (NIEC)

Bidding will be conducted through the International Competitive Bidding procedures as specified in the World Bank's <u>Guidelines: Procurement of Goods, Works and Non-Consulting Services under IBRD Loans and IDA Credits & Grants by World Bank Borrowers January 2011</u> ("Procurement Guidelines"), and is open to all eligible bidders as defined in the Procurement Guidelines. In addition, please refer to paragraphs 1.6 and 1.7 setting forth the World Bank's policy on conflict of interest.

 - Filled Bid-Securing Declaration (page 56 of IFB)
 - Financial Statements for the last 2 years(p.39 of IFB)
 - Proof (document evidence) of annual turnover of a minimum \$USD 100,000
 - Proof(document evidence) of at least two completed contracts of similar nature (p. 39 of IFB)

Failure in providing the requested documents shall render bid non responsive and will constitute grounds**for disqualification of the bidder**.
