Bids will be conducted through International Competitive Procurement (ICB).

All Bids must be accompanied by a "BID SECURITY DECLARATION" valid for two years using the form provided in section 6 of the ITB.

A pre-bid meeting shall be conducted by SCAA Academy on $01^{st\,D}$, *December 2019* <u>@ 10:00 AM (Local time)</u> in the main conference hall at the 01^{st} floor of the SCAA academy at Aden Abdulle International Airport, Waberi district, Mogadishu. Bids submitted shall remain valid for a period of 90-days after the deadline submission of bids in accordance with ITB 16 in the Bid Data Sheet (BDS). The time allowed for the completion of the construction works is within 6 *Calendar months* (180-days) from the contract signing date.

Bidding documents should be delivered in person to the address below by 15" *December 2019 at* 10:00 am (*Local Time*). Late Bids will be rejected and returned unopened.

Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **10:00** am East Africa time, on **15th of January 2020**.
